Currently, there are 22 groups of products divided into 132 product categories that require mandatory CCC Mark Component parts of finished products, spare parts and replacement parts, may in some cases require CCC certification Products applied for CCC certification must conform to Chinese standards. China CCC Certification is a mandatory safety and quality compliance system for certain products sold, imported, or used commercially in China. This involves checking whether the product is listed in the CCC catalog and if there are corresponding implementation regulations for CCC.
